Owners wishing to enter their boats in the 2015-2016 Racing Series must complete this form and return it together with:

- A copy of the **current** certificate of insurance for the vessel
- A copy of the **current** certificate of registration for the vessel
- A signed** SR Equipment Compliance form (Category 3, 4 or 6 safety form, as required)

Documentation must be submitted to Race Committee Member personally or by email (racing@pasc.com.au) 48 hours before the boat competes in its first race.

Entries received within 48 hours of a race will be considered as a 'Casual entry'.

The onus of correct registration and series nomination is with the racing skipper.

NOTES: All crew shall be a member of the PASC after an initial three races.(Twilights Excepted) YA membership is automatic with PASC membership. Skippers are responsible for informing the Race Committee of new crew members. Any boat failing to observe this rule may be subject to protest.

Yacht owners or skippers are to submit their signed SR Equipment Compliance form (Category 3,4 or 6 safety form, as required) at the beginning of each season. Skippers are responsible for ensuring the SR Equipment Compliance form is properly completed and that any changes to the boat, its equipment or crew does not invalidate the compliance. A boat may be protested if it is non-compliant. It is not necessary to have the PASC Safety Officer present when the form is completed, however boats will be spot checked during the season for compliance. Any boat that does not comply will be subject to protest.

ENTRY FEE EXPLANATION - A season entry fee for all races (including River, Gulf and Twilights) is \$174. An early bird discount of \$120 is available if all documents are submitted for entry **before 5 pm** on **14th October 2015**. After 14th October 2015 the fee will be \$174.

Alternatively skippers can choose to enter individual races at a cost \$10 per race (see casual entry below) or by series. Series costs are calculated as a discount of 40% on the casual rate as follows:

Summer Series	\$78
River only	\$40
Gulf only	\$40
Summer Twilights	\$66
Winter River races	\$30

Fees for special events such as the Port Line Cup and the 3 Day Gulf events will be advised and published separately in the 'Event' material.

All race fees will be charged to the members' account following receipt of the nomination form. Fees not paid within 4 weeks of the date of invoice will mean the boat will be considered as a 'non competitor' and a DNC will be recorded.

If a boat appears on TopYacht without the appropriate nomination form and associated paperwork they will be recorded as a 'non-competitor' and a DNC entered into TopYacht.

A '**Casual Entry**' shall pay a fee of \$10 per race and provide the other required documents to a member of the Race Committee at least 2 hours prior to the Warning Signal. Such entries are not eligible for points towards series prizes and trophies, but may receive individual race prizes on the day.
